

**ORDINANCE NO. 2024-03-01**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF QUINLAN, TEXAS,  
DECLARING UNOPPOSED CANDIDATES IN THE MAY 4, 2024 GENERAL CITY  
ELECTION, ELECTED TO OFFICE; CANCELING THE ELECTION; PROVIDING A  
SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Quinlan, Texas ("City") General Election was called for May 4, 2024, for the purpose of electing members to the City Council of the City of Quinlan, Texas ("City Council"); and

**WHEREAS**, the City Secretary has certified in writing that no person has made a declaration of write-in candidacy, and that each candidate on the ballot is unopposed for election to office; and

**WHEREAS**, under these circumstances, Chapter 2, Subchapter C of the Election Code, authorizes the City Council to declare the candidates elected to office and cancel the election.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF QUINLAN, TEXAS:**

**Section 1.** That, the following candidates, who are unopposed in the May 4, 2024 City General Election, are declared elected to office, and shall be issued certificates of election following the time the election would have been canvassed:

Dwayne Bowman, Council Member, Place 1  
Tommy Underwood, Council Member, Place 3  
Miguel Serrano, Council Member, Place 5

**Section 2.** That, the May 4, 2024 General Election is cancelled, and the City Secretary is directed to cause a copy of this ordinance to be posted on Election Day at each polling place that would have been used in the election.

**Section 3.** That, it is declared to be the intent of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this ordinance are severable, and if any phrase, clause, sentence, paragraph, or section of this ordinance is declared invalid by the jurisdiction, the invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or section of this ordinance since the City Council would have enacted them without the invalid portion.

**Section 4.** That, this Ordinance shall be effective from the date of its adoption.
