**CHECKLIST CERTIFICATION FOR UNCONTESTED INTESTATE ESTATE §401.003

Before the court will set your case for a hearing for an uncontested prove-up of an intestate estate by agreement pursuant to §401.003, you must complete, sign, and file this form showing that you have satisfied all the necessary prerequisites.

- ☐ 1. The *Checklist Certification for Determination of Heirship* has been completed and filed. §401.003(b).
- ☐ 2. Application includes last 3 digits of Applicant's and Decedent's SSN and DL or explains why omitted as required by Texas Estates Code §256.052.
- ☐ 3. General citation has been posted.
- ☐ 4. The proper inquiries have been made and the designated Independent Administrator is qualified to serve. §304.003.
- ☐ 5. **All** Distributees have agreed and consented to creating an Independent Administration of the estate and the proper documents evidencing all distributees' consent have been filed with the Court. §401.003
- ☐ 6. **All** Distributees have agreed collectively on the designation of a qualified person, firm, or corporation to serve as Independent Administrator and the proper documents evidencing all distributees' consent have been filed with the Court. §401.003
- ☐ 7. **All** Distributees have been served with citation and notice of the Application, or proper waivers for the issuance of citation have been filed, or the distributee has entered an appearance in Court. §401.004(b)
- ☐ 8. **If** requesting waiver of bond, the proper waiver(s) must be filed with the Court evidencing all distributees' understanding that a bond is required and that they are waiving the requirement for the Independent Administration to be bonded. §401.005
- ☐ 9. All testimony admitted into evidence must be reduced to writing. A *Proof of Death and Other Facts* (and if necessary, any Disinterested-Witness Testimony) has been prepared, ***executed***, and filed with the Court. If testimony is by written deposition, it must comply §51.203 and with the TRCP. If testimony is by written deposition, it must comply §51.203 and with the TRCP.
- ☐ 10. I have reviewed with Applicant the applicable instructions of the court regarding the duties and responsibilities of the executor/administrator. The document has been ***executed*** and filed with the Court.
- ☐ 11. The *Executor/Administrator General Information Sheet* has been completed, ***executed*** and filed with the Court.
- ☐ 12. The proposed order has been filed.
- ☐ 13. Oath has been prepared for the Independent Administrator in accordance with Texas Estates Code Chapter 305 and will be presented to the Court on the day of the hearing.
