ORDER IMPOSING CONDITIONS OF COMMUNITY SUPERVISION

It is, therefore, ORDERED by the Court that the **DEFENDANT IS PLACED ON COMMUNITY SUPERVISION FOR MONTHS SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS.** The Defendant shall:

- 1. Commit no offense against the laws of this or any State or of the United States or any other Country. Defendant shall notify the Community Supervision Officer in charge of the case within forty eight (48) hours of being arrested and/or charged with a criminal offense.
- 2. Avoid injurious or vicious habits; abstain from the use of alcoholic beverages; abstain from the use of narcotic or habit forming drugs without a doctor's prescription.
- 3. Immediately report, in person, to the Hunt County Community Supervision (HCCSO) Office located at 4515 Stonewall, Greenville, Texas, (903) 455-9563. Thereafter, Defendant shall report in person to the HCCSO on a monthly basis.
- 4. Permit the Community Supervision Officer to visit at their home or elsewhere.
- 5. Work faithfully at suitable employment as far as possible.
- 6. Not change employment or place of residence without the prior permission of the Community Supervision Officer or by further Order of the Court.
- 7. Remain in the State of Texas unless given permission to depart by the Community Supervision Officer in charge of the case.
- 8. Not depart from the supervising county or county of residence for more than 48 continuous hours unless given permission to depart by the Community Supervision Officer in charge of the case.
- 9. Support their dependents.
- 10. Pay a monthly community supervision fee pursuant to Art.42A.652 as assessed by the Court in the Judgment entered in this cause at a rate of \$60.00 per month.
- 11. Pay their fines, court costs, reimbursement fees and restitution, if assessed by the Court, in accordance with the Judgment entered in this cause.
- 12. Perform _____ hours of Community Service Restitution at a governmental, charitable, or non-profit organization as assigned by the Community Supervision Officer in charge of the case, at a rate of no less than 10 hours per month, beginning within thirty (30) days of today's date and be responsible for any costs of supervision.
- 13. Submit urine, blood, breath, saliva or hair samples to the Community Supervision Officer in charge of their case at any time requested, to be used for the detection of alcohol or drug usage. Defendant shall pay all costs associated with the above listed.
- 14. Obey all rules and regulations of the Community Supervision Office.
- 15. Refrain from disorderly conduct, abusive, indecent, profane or vulgar language, or disturbing the peace while present at the Community Supervision Office.

<u>CONDITION #16 APPLIES ONLY IF DEFENDANT UNDER 21 YEARS OF AGE AND IS PLACED ON COMMUNITY</u> SUPERVISION FOR THE OFFENSE OF DRIVING WHILE INTOXICATED (DWI):

16. Within 30 days, install and maintain a Department of Public Safety approved vendor ignition interlock device on the defendant's vehicle or vehicle most regularly driven by the defendant. Have such device inspected as directed by your Department of Public Safety approved vendor for the ignition interlock devices. Do not operate any vehicle that is not equipped with such approved ignition interlock device. Said device shall not be removed until the expiration of the term of community supervision or further Order of the Court. Abide by all terms and conditions of the interlock device provider.

<u>CONDITIONS #17 - #19 APPLY ONLY IF PLACED ON COMMUNITY SUPERVISION FOR THE OFFENSE OF DRIVING WHILE INTOXICATED (DWI):</u>

- 17. Successfully complete, provide the Community Supervision Office with a certificate of successful completion, and pay all costs associated with the following program(s) as set forth hereinbelow:
 - (a) Court-approved Substance Abuse Evaluation within 60 days of Judgment;
 - (b) Court-approved DWI Educational Program within 180 days of Judgment;
 - (c) Court-approved Victim Impact Panel within 90 days of Judgment
- 18. Successfully complete, provide the Community Supervision Office with a certificate of successful completion, and pay all costs associated with any and all treatment recommendations of the Substance Abuse Evaluation per the direction of the Community Supervision Office.
- 19. If subsequently investigated for the offense of Driving While Intoxicated, perform any and all field sobriety tests including but not limited to the Portable Breath Test and the Intoxilyzer.

CONDITIONS #20 - #23 APPLY ONLY IF PLACED ON COMMUNITY SUPERVISION FOR THE OFFENSE OF DRIVING WHILE INTOXICATED 2nd (DWI 2nd) or DRIVING WHILE INTOXICATED BAC >=0.15:

- 20. Successfully complete, provide the Community Supervision Office with a certificate of successful completion, and pay all costs associated with the following program(s) as set forth hereinbelow:
 - (a) Court-approved Substance Abuse Evaluation within 60 days of Judgment;
 - (b)(i) For DWI 2nd Court-approved Repeat Offender DWI Educational Program within 180 days of Judgment; OR
 - (b)(ii) For DWI BAC >= .15 Court-approved DWI Educational Program within 180 days of Judgment;
 - (c) Court-approved Victim Impact Panel within 90 days of Judgment.
- 21. Successfully complete, provide the Community Supervision Office with a certificate of successful completion, and pay all costs associated with any and all treatment recommendations of the Substance Abuse Evaluation per the direction of the Community Supervision Office.
- 22. Within 30 days, install and maintain a Department of Public Safety approved vendor ignition interlock device on the defendant's vehicle or vehicle most regularly driven by the defendant. Have such device inspected as directed by your Department of Public Safety approved vendor for the ignition interlock devices. Do not operate any vehicle that is not equipped with such approved ignition interlock device. Said device shall not be removed until the expiration of the term of community supervision or further Order of the Court. Abide by all terms and conditions of the interlock device provider.
- 23. If subsequently investigated for the offense of Driving While Intoxicated, perform any and all field sobriety tests including but not limited to the Portable Breath Test and the Intoxilyzer.

<u>CONDITIONS #24 - #25 APPLY ONLY IF PLACED ON COMMUNITY SUPERVISION FOR THE OFFENSE OF ASSAULT FAMILY VIOLENCE:</u>

- 24. Successfully complete and provide the Community Supervision Department with a certificate of successful completion, and pay all costs associated with the following program(s) within the time period(s) set forth hereinbelow:
 - (a) Substance Abuse Evaluation within 90 days of Judgment;
 - (b) Domestic Violence counseling within 180 days of Judgment.
- 25. Successfully complete, provide the Community Supervision Department with a certificate of successful completion, and pay all costs associated with any and all treatment recommendations of the Substance Abuse Evaluation per the direction of the Community Supervision Office.

<u>CONDITION #26 - #27 APPLIES ONLY IF PLACED ON COMMUNITY SUPERVISION FOR THE OFFENSE OF DRIVING WHILE LICENSE INVALID:</u>

- 26. Within sixty (60) days of this order, obtain and maintain a valid Texas Driver's License and provide proof thereof to the Hunt County Community Supervision Office.
- 27. Within sixty (60) days of this order, maintain the minimum required insurance for any and all vehicles owned by Defendant and provide proof thereof to the Hunt County Community Supervision Office.
