- III. Incompetent to stand trial; or
- IV. Being detained for a violation of the condition(s) of a previous release related to the safety of a victim of the alleged offense, or to the safety of the community under article 17 of the Code of Criminal Procedure.

Defendant respectfully request the Court release the Defendant on a personal bond or by reducing the amount of bond required.
