## **OCCUPATIONAL LICENSE PETITION**

READ THIS PACKET CAREFULLY

A person must file a verified petition with the clerk in the COUNTY and PRECINCT where they reside or where the offense occurred that resulted in the suspension.

Once ALL REQUIRED DOCUMENTS are obtained, you must file with the court to obtain an Occupational License Hearing Date.

The fee for filing an Occupational License in the Justice Courts is \$54.00.

You must bring ALL REQUIRED DOCUMENTS (these are listed in the packet you received in Section 5) to your Occupational License Hearing. If you do not have **all required documents** your Occupational License may be **DENIED**.

Please note\*\* when submitting the hours needed for operation of a motor vehicle, this ONLY includes the time spent behind the wheel of the vehicle, not the hours worked, or attending school. You may need extra paper in order to list the times.

(example: you live 30 minutes from your 8:00 AM to 5:00 PM job with lunch from 12:00 PM to 1:00 PM. You will need to write down following:

from 7:00 AM to 8:00 AM

from 12:00 PM to 1:00 PM

from 5:00 PM to 6:00 PM
