<b>JOB TITLE:</b>	Pretrial Bond Officer
<b>LOCATION:</b>	Greenville, Texas
<b>QUALIFICATIONS:</b>	A minimum of a high school diploma or equivalent.
<b>ADDITIONAL REQUIRMENTS:</b>	Must have a valid Texas driver's license, provide proof of vehicle insurance, and have adequate transportation, must be able to pass a criminal background check and drug screen. Must be able to travel for required annual training.
<b>DUTIES:</b>	Supervise a caseload of offenders placed on pretrial supervision. Specific duties determined by the type of caseload assigned and may include, but not be limited to the following: enforce any orders of the court and monitor offender's compliance with conditions of bond, conduct routine office and field contacts on offenders, conduct and observe urinalysis, provide referrals to offenders for services and programs to address criminogenic needs, conduct assessments and supervision plans, conduct intakes, report violations to the court, maintain case files and chronological reports/ documentation, assist department staff, maintain current educational and training requirements, travel to/from the courthouse, maintain a professional appearance, follow all personnel and departmental policies, plus any additional duties assigned by the Director.
<b>KNOWLEDGE, ABILITIES AND SKILLS:</b>	Possess excellent written and verbal communication skills. Ability to follow written and verbal instructions. Ability to work in harmony with offenders, court personnel, city/county personnel, law enforcement agencies, the public, and CSCD staff.
<b>ESSENTIAL PHYSICAL DEMANDS:</b>	Reading and understanding complex documents, both paper and electronic. Ability to effectively communicate both internally and externally. Ability to lift boxes, supplies, case files, bending, standing, sitting, walking, kneeling, speaking, hearing, significant data entry, driving, ability to manage stress in meeting deadlines and changes, and other physical efforts that may be required to carry out the job. Ability to be trained in and conduct defensive and safety procedures.
<b>ENVIRONMENTAL FACTORS:</b>	Work indoors and outdoors. Works with felony and misdemeanor defendant/offenders. Conducts field work in the community by making home and/or work visits to offenders, including high crime areas of the jurisdiction. Conduct jail visits. Works in criminal courts, contact with courthouse personnel, law enforcement and community agencies.
<b>SALARY:</b>	Starting salary for an entry level position is \$40,000.00. Salary based on experience and education is negotiable. Benefits included from Employees Retirement System of Texas (ERS) and Texas County & District Retirement System (TCDRS).
