## ADDENDUM # TWO

### RFP #266-25: Request for Proposals for Inmate Telephone Systems - Hunt County, Texas

October 10, 2025

The following information is being provided to clarify the proposal requirements and address questions received as of this date:

#### Questions:

- Will the County please confirm that in order to ensure the selected vendor is financially stable and can provide the services required through the contract term, all vendors are required to disclose any pending, current, or prior bankruptcy filings.**

**Answer:** Yes. The County requires that all vendors disclose any pending, current, or prior bankruptcy filings. This information is necessary to ensure the financial stability of the selected vendor and the vendor's ability to perform all obligations under the contract for its full term.
- On October 7, the FCC issued a new Report and Order proposing a ban on commissions and introducing new rate caps for inmate calling and video visitation. These rules are scheduled to be voted on later this month, with compliance required by early 2026 if adopted. Given the significant potential impact on pricing under this contract, does the Agency intend to revise the RFP to include financial options that align with the proposed regulations?**

**Answer:** Hunt County is aware of the Federal Communications Commission's recent actions and proposals regarding inmate calling and video visitation rates and commissions. At this time, these proposed rules have not yet been formally adopted, and no compliance requirements are currently in effect.

Should the FCC adopt final regulations that materially impact the pricing structure or commission terms during the contract period, Hunt County will review the final rule and take any necessary steps to ensure compliance with applicable law. Any adjustments required as a result of those regulations would be addressed through a formal contract amendment or future solicitation, as appropriate.

For the purposes of RFP #266-25, respondents should base their financial proposals on the current regulatory framework in effect as of the proposal due date. **All other terms, conditions, and specifications of RFP #266-25 remain unchanged.**

3. **Who are the members of the selection committee?**

**Answer:** The committee will consist of the following representatives Lieutenant Wendy Karr, Capt. Daniel Looney, Lt. Clifton King and Communications Director Virgina Phillips, with the Sheriff's Department. The Purchasing Department will provide assistance to the committee but will not have a vote in the final recommendations of the committee to the Commissioner's Court.
