TO THE HONORABLE JUDGE OF SAID COURT:

- 2. Decedent died intestate on April 30, 2020, at 4215 Joe Ramsey Boulevard E, Greenville, Hunt County, Texas, at the age of 62 years. Decedent's domicile at the time of his death was 4470 CR 2208, Greenville, Hunt County, Texas. The last three digits of the social security number of Decedent are 667. The last three digits of the driver's license number of Decedent are 131.
- 3. This Court has jurisdiction and venue is proper because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of his death.

WHEREFORE, Applicant prays that citation with respect to this Application for Independent Administration and Letters of Administration pursuant to Section 401.003 of the Texas Estates Code be issued and served as required by law to all persons interested in this Estate; that it be adjudged to be advisable and in the best interests of the Decedent's estate for Julie Allen to be appointed to serve as Administrator under the provisions of Section 401.003 of the Texas Estates Code; that Letters of Administration be issued to Julie Allen; and that no action be had in this court in relation to the settlement of such estate other than the return of an inventory, appraisement, and list of claims of such estate or an affidavit in lieu of the inventory, appraisement and list of claims; and that all other Orders be entered as the Court may deem proper
